## GERMAN MANUFACTURER SELECTS WICHITA REGION FOR NEW NORTH AMERICAN PARTS AND ASSEMBLY FACILITY

**HASBERGEN-GASTE, Germany / EL DORADO, Kan., Dec. 2, 2025** – AMAZONE, a leading German agricultural machinery manufacturer, has chosen the Wichita region for its new North American parts and distribution facility, marking a significant step in the company's continued expansion in the United States.

The 30,000-square-foot facility, located on a 6.5-acre site in El Dorado, will be used for the storage and shipment of AMAZONE agricultural machinery and spare parts across the U.S., as well as for final assembly. The new operation complements AMAZONE's growing presence across North America and reinforces its long-term commitment to serving customers in one of the country's most important agricultural regions.

"Despite the current challenging market conditions, we believe strongly in the potential of the U.S. agricultural sector. Establishing our presence in Kansas underscores our confidence in the region and our commitment to growing alongside our partners and customers. El Dorado's ideal logistical location enables us to respond faster, deliver more efficiently, and better support the U.S. market," said Christian and Dr. Justus Dreyer, chairmen of the management board and owners of the AMAZONE Group.

"I'm incredibly happy and excited for our new location in El Dorado, a milestone that truly reflects how far we've come. From being the first employee in the USA to witnessing our growth to this point, it's clear that the hard work of our team and AMAZONE has made this achievement possible," shared Marc Heater, Director of Sales and Marketing, AMAZONE USA.

The decision to expand to El Dorado reflects the region's strategic advantages, including its central location along Interstate 35 between Kansas City and Wichita, proximity to major rail and air cargo hubs, and access to a labor market with highly trained technical specialists.

"AMAZONE's investment in Kansas is a powerful example of how the state's proactive international engagement delivers results," Kansas Department of Commerce Deputy Secretary Joshua Jefferson said. "The company exemplifies the international partnerships the Kelly-Toland administration is cultivating to elevate Kansas' competitiveness on the global stage."

AMAZONE has been active in North America since the 1970s, initially through the sale of fertilizer spreaders under the EasyFlow and New Idea brand names. Building on that success, the company founded its subsidiary AMAZONE Inc. in Canada in 2016 and AMAZONE USA Inc. in Delaware in 2021, establishing a strong North American foundation with more than 30 employees supporting local farmers and dealers across the continent.

"We're proud that AMAZONE chose the Wichita region for its new North American operations. This decision reflects the strength of our workforce, the region's central location and the collaborative business environment that makes Kansas such a compelling choice for global companies," said Jeff Fluhr, President of the Greater Wichita Partnership.
